Barber Shops/Salons/Body Art	Phase I - May 6	Services can resume under Phase I conditions	<a href="#">ADH Phase I Directive</a>
Commercial Lodging Limitations on Out-of-State Travelers	Phase I - May 6	Out of state travelers permitted but travelers from “hot spots” are advised to self-quarantine for 14 days (see end of business protocols for information)	<a href="#">ADH Business Protocols (includes lodging guidance at end)</a>
Dental Services	Phase I - May 11	Elective dental services can resume subject to Phase I requirements	<a href="#">ADH Phase I Directive</a>

Places of Worship	Phase I - May 4	Worship permitted at Places of Worship under Phase I directives:	<a href="#">ADH Phase I Guidance</a>
